PURPOSE OF THE COURSE

The purpose of this 1-hour class will be to assist students in exploring Anglican theological understandings of the Eucharist and becoming conversant with both the basic shape of the Eucharist and the many authorized liturgical Eucharistic rites within both the Anglican Church of Canada and the Episcopal Church. Additionally, the course is meant to assist students in exploring their understanding of liturgical leadership within the Eucharist and practicing that leadership, becoming attentive to the impact of their leadership on the assembly. Finally, students will explore current questions related to the Eucharist: the relationship between Baptism and Eucharist and questions and issues raised by the experience of the pandemic.

COMPETENCE OBJECTIVES

By the end of the course, participants will be able:

- 1. To articulate Anglican/Episcopal Church's theological understandings of the Eucharist and its importance in the life of a Christian and in the life of a Christian community.
- 2. To describe the essential shape of the Eucharist and to identify that shape within current authorized Eucharistic texts.
- 3. To preside assist or serve as a deacon at the Eucharist in ways that are attentive to the impact of that presiding, assisting, diaconal service on the assembly.
- 4. To describe perspectives and the rationale of each perspective on a) the relationship between Baptism and Eucharist and b) the questions and insights about the Eucharist gleaned under the conditions of the Covid 19 pandemic.

PREREQUISITES

This course is **restricted** to Anglican M.Div. students and students in the ADDS program for diaconal postulants, unless by special permission of the instructor.

Based on their participation in-person in the class and assigned readings, students will also be required to answer three of the five questions below with relevant abbreviated citations. (For each question, response to be one page, Word format, 500-600 words, single-spaced, with abbreviated citations (author, abbreviated title) for each response. Answers should reflect what was learned in the course and reference the required or supplementary text(s). As you choose and respond to your questions, demonstrate your mastery of the competence objectives.

Your responses to the questions are due via email to the Instructor by April 1, 2026, If the paper does not reflect substantial understanding and appreciation of the subject matter and competence objectives, a re-write will be required and will be due by April 15, 2026.

1. A new deacon has been assigned to your parish/congregation and comes to you, the rector/priest in charge, and asks the following question: "What am I allowed to do



liturgically here in the Eucharist?" What is your response, and what is the rationale for your response? What else might you mention to the deacon about his/her/their role that is relevant?

- 2. You are planning the Eucharistic liturgy for the Feast of Pentecost in a parish/congregation in which inclusive/expansive language in liturgy has been the parish's/congregation's and your practice. What Eucharistic Prayer do you choose and why? What else might be important to consider in terms of the other liturgical choices?
- 3. You are teaching a class on the Eucharist within an Anglican/Episcopal context. Part of the class will involve your own teaching about what the Eucharist is. Both former Roman Catholics and former Evangelicals will be in the class. What are your major points?
- 4. Another pandemic has arrived, and people are prohibited from physically gathering for the next three months. You and your leadership need to decide what you will offer to your congregation in terms of Eucharistic worship (or not), how you will offer it and what the rationale is for what you will do. What do you decide and why?
- 5. You are putting together a new liturgy team that will plan Eucharistic liturgy and music for the coming year. The team is highly motivated. What do you have the team read, or view or discuss in preparation for the first meeting? Why these choices? What other resources will you draw on for the course and why?

COURSE POLICIES/REQUIREMENTS

- 1. Attendance: For a weekly course, VST requires at least 80% attendance. For an intensive course (this is an intensive course), VST requires 100% attendance.

- on any assignment that is INC. The re-written assignment is due two weeks after the work is returned. The final evaluation for an assignment can be APP or NAPP after a re-write.
- o For a passing grade in the course, all assignments must be Approved.

All assignments in courses are due on the dates specified in the syllabus. Failure to submit an assignment on time will be noted in the narrative evaluation of an assignment.
